- 3. Holding national and international level conferences and training on Entrepreneurship Development and Sustainable

Development goals.

4. Providing a platform to youths to explore lucrative career opportunities.

5. Providing and sharing information about upcoming events, seminar, workshop etc which is of beneficial.

6. Capacity building of 10 core team members for Youth4Change

Roles and Responsibilities of Sane Guruji Shikshan Prasarak Mandal's Nasik Road Art's and Commerce College, Baragaon Pimpri, Sinner, Nashik

- 1. A Program officer shall be assigned from the College for smooth coordination between the College and the CYDA.
- 2. The College shall identify volunteers for the formation of Youth4Change to organize events/competition within the college or virtually.

- 4. The College shall provide its premises for organizing workshops, sessions, events and social actions.
